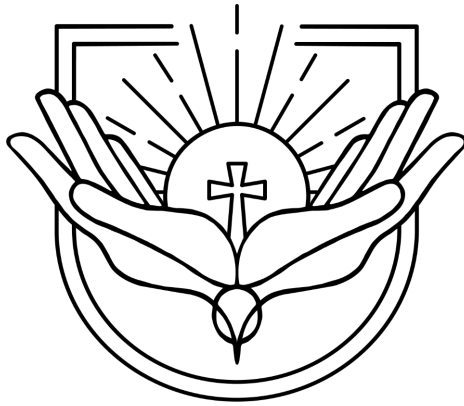

The Well: Young Adult Conference Exhibitor Rules and Regulations

- The Office for Ministry with Young Adults (OMYA) reserves the right to accept or reject any Exhibitor/Vendor application for any or no reason.
- Categories for applicants are (1) Vendors are categorized as organizations selling products or services (e.g. Sock Religious); (2) Exhibitors are organizations that are not selling products or services, but will focus on promoting their ministry (e.g. missionary groups, young adult ministries, religious orders). (3) A Vendor/Exhibitor will be considered a Sponsor if the organization has made a donation to the conference exceeding the \$100 vendor fee. Additional information regarding the benefits for different types of sponsors can be found on our webpage: <https://phillyyam.org/become-a-sponsor/> For example, sponsors who make a donation exceeding \$1,000, will receive 2 complimentary conference passes.
- Vendors are required to pay a fee of \$100 which directly supports the overhead costs of the conference. Vendor space reservations are not confirmed until receipt of payment.
- OMYA and the Sheraton Hotel are not responsible for any articles, personal property or goods lost, stolen or damaged while at the conference. No surveillance or security is provided.
- Exhibitors/Vendors must register at the Exhibitor/Vendor Registration Table prior to setup.
- Exhibitor/Vendors' goods or displays may not occupy space outside of their designated area.
- Exhibitors/Vendors are responsible for tidying up their designated areas and removing all displays following the conference.
- All Exhibitors/Vendors must register and pay for their representatives' attendance at the conference, unless they are Sponsors that have made a donation that exceeds \$1,000.
- No pets of any type or size are allowed.
- Vendors are responsible for collecting and submitting PA sales tax and complying with Pennsylvania Sales and Use tax regulations.
- Exhibitors/Vendors will not sell and/or display any items, advertising, or merchandise of a sexual, political, or inappropriate nature. Any vendor displaying items deemed inappropriate by OMYA or the Sheraton will be asked to remove the items. Any Exhibitor/Vendor not cooperating with such requests may be asked to leave the conference without refund.
- In keeping with the Catholic mission of this event, all Exhibitors/Vendors represented must be in conformity with the Magisterial Teaching of the Catholic Church. If the mission or practices of an organization conflict with Catholic teaching, OMYA reserves the right to decline that organization for tabling.
- Exhibitors/Vendors must comply with all rules and regulations of the conference. Signage must be limited to one's own table.

- Exhibitors/Vendors will not sell or distribute any food or beverages at the Sheraton hotel.
- Exhibitors/Vendors are asked to respect neighboring Exhibitors/Vendors, conference participants, and Staff. Any Exhibitor/Vendor causing excessive noise, engaging in inappropriate behavior and/or being uncooperative will be asked to leave the conference without refund.
- Non-compliance with safety regulations, as determined by OMYA or the Sheraton will result in the loss of your vendor space and removal of your property from the conference, without refund.

RELEASE AGREEMENT

The undersigned Exhibitor/Vendor waives, releases, and forever discharges all claims against the OMYA, Archbishop of Philadelphia (and his successors and assigns), and Archdiocese of Philadelphia, and their respective affiliates, members, directors, officers, employees, volunteers, agents, contractors, and representatives (hereinafter collectively "Released Parties") for any injuries, damages, losses, or claims, whether known or unknown, which arise during or result from the OMYA conference described herein, except and only to the extent caused by the gross negligence or intentional misconduct of any of the Released Parties which shall not be imputed to the other Released Parties.

Exhibitor/Vendor shall be liable for any and all damage to or incurred by the Sheraton Hotel or OMYA, its staff, employees, and volunteers as result of the use and occupancy of the premises by Exhibitor/Vendor, their agents, employees, or volunteers, or any person coming upon the premises in connection with the undersigned's use and occupancy of the premises. By signing this application, you confirm that you have read, understand, and comply with the Rules and Regulations as stated and agree to the foregoing Release Agreement.
